## **1 July to 4 December 2019**

Non-provisional taxpayers using eFiling or the SARS MobiApp

Provisional taxpayers using eFiling

File your return **HONESTLY, ACCURATELY**  
and **ON TIME** to avoid **PENALTIES**

# Don't **QUEUE** if you don't have to

## 2019 TAX SEASON

**LET'S DO RIGHT

You do not need to file a return if **ALL** of these apply to you:

1. Your total salary for the year before tax is not more than R500 000; and
2. You have only one employer; and
3. You have no car allowance/ company car/ travel allowance or other income (e.g. interest or rental income); and
4. You are not claiming tax-related deductions/rebates other than pension contributions made by your employer.

**Only submit if your financial circumstances changed between 1 March 2018 and 28 February 2019, and you want to claim or declare:**

- Medical scheme contributions
- Medical expenses not paid by a medical scheme
- Retirement annuity fund contributions
- Rental income received
- Income received from a foreign source; or
- Interest received from local and foreign investments

# Did you receive an SMS from SARS?

If you filed a return in 2018, but you were not required to do so, you may receive an SMS with a simulated calculation from SARS.

This means that you don't have to file this year, unless your financial circumstances have changed since February 2018.

You can file if you:

- Have a new job; and/or
- Were not employed for a full 12 months; and/or
- Received income from a foreign source; and/or
- Received interest from local and foreign investments; and/or
- Are getting additional income like rental income; and/or
- Want to claim for any medical scheme contributions, medical expenses not paid by a medical scheme, retirement annuity fund contributions.
