KENNISGEWING VAN VOORNEME WORD HIERMEE GEGEE INGEVOLGDE ARTIKEL 116(3) VAN DIE MFMA VIR DIE VERLENGING VAN TENDER SBM 50/18/19: DEEL 1: DIE AANSTELLING VAN RAADGEWENDE INGENIEURSWESE DIENSTE VIR VERSKEIE PROJEKTE VIR 'N 3 JAAR PERIODE (01 JULIE 2019 TOT 30 JUNIE 2022).

SBM 50/18/19: DEEL 1: Die aanstelling van raadgewende ingenieurswese dienste vir verskeie projekte vir 'n drie-jaar periode (01 Julie 2019 tot 30 Junie 2022) was verleng tot 30 Junie 2023 en moet verder verleng word vir die volgende redes:

- i) Alle kontrakte moet geldig bly op 'n maand tot maand basis, totdat die kontrakte vir die nuwe tender geteken is; en
- ii) Alle kontrakte moet geldig bly waar werkpakkette uitgereik was tot die voltooiing van die relevante kontrak.

DEEL 2 van tender SBM 50/18/19 behels die uitreiking van individuele werkpakkette aan die gekeurde konsultante van DEEL 1 en individuele tender ooreenkomstes word mee ingetree. Die tydlyne op DEEL 2 werkpakkette gaan oorskry met die van die oorspronklike tender SBM 50/18/19, wat toegelaat word in terme van die regulasies en beleid van die Raad, egter deur te verseker dat die hele tender SBM 50/18/19 aktief en relevant bly, is daar 'n noodsaaklikheid om DEEL 1 te verleng soos hierbo uiteengesit.

Belangrik om op te let is dat die verlenging van DEEL 1 is net om te verseker dat die bestaande werkpakkette wat uitgereik is, voltooi kan word en dat geen nuwe werkpakkette uitgereik kan word op tender SBM 50/18/19 van 01 Julie 2023, omdat tender SBM 37/21/22 in daardie verband gebruik moet word.

NOTICE OF INTENT IS HEREBY GIVEN IN RESPECT OF SECTION 116(3) OF THE MFMA FOR THE EXTENSION OF TENDER SBM 50/18/19: PART 1: THE APPOINTMENT OF CONSULTING ENGINEERING SERVICES FOR VARIOUS PROJECTS FOR A THREE-YEAR PERIOD (01 JULY 2019 TO 30 JUNE 2022).

SBM 50/18/19: PART 1: The appointment of consulting engineering services for various projects for a three-year period (01 July 2019 to 30 June 2022) were extended till 30 June 2023 and must be extended further for the following reasons:

- i) All contracts must remain valid on a month to month basis, till the contracts are signed for the new tender; and
- ii) All contracts must remain valid where work packages were issued till completion of the relevant contract.

PART 2 of tender SBM 50/18/19 entails the issuance of individual work packages for consultants vetted as part of PART 1 and individual tender agreements are entered. Timelines on PART 2 work packages will overlap with that of the original tender SBM 50/18/19, which is allowed for in terms regulations and policy of Council, however to ensure that the full tender SBM 50/18/19 remains active and relevant, there's a need to extend PART 1 as outlined above.

Important to note that the extension of PART 1 is only to ensure that existing packages issued, can be completed and no new work packages can be issued on tender SBM 50/18/19 from 1 July 2023, as tender SBM 37/21/22 needs to be utilized in that regards.
